DECISION no. 10/2010

Under Art. 155 of the Act dated 14 June 1960 on the Administrative Procedure Code (Journal of Laws of 2000, no. 98 item 1071 as amended) and Art. 40 section 1 of the Act dated 18 December 2003 on plant protection (Journal of Laws of 2008, no. 133, item 849 as amended), having examined a request dated 12 July 2010 **I change decision no. 8/2005 dated 1 May 2005 as amended by decisions no. 29/2005 dated 23 December 2005, no. 3/2007 dated 4 April 2007 and no. 2/2008 dated 14 April 2008.** The decision made shall be now read as follows:

I authorize

to conduct tests of effectiveness of plant protection chemicals

from the group of acaricides, bacteriocides, fungicides, herbicides, insecticides, molluscicides, growth regulators, adjuvants, biostimulators and biopreparations in field cultivation (cereals, rape, maize, beetroots, potatoes, leguminous plants), in orchard cultivation (fruit trees: apple, pear, plum, cherry, sweet cherry, peach, apricot and strawberries), in vegetable cultivation (such as: brassica, nightshade, cucurbits, bulb, root, leaf and leguminous), in cultivation of decorative plants and on meadows, pastures, lawns, idle lands, fallows and urban trees.

According to Art. 50 of the Act dated 4 March 2010 on provision of services in the territory of the Republic of Poland (Journal of Laws, no. 47, item 278) this authorization is an authorization issued for indefinite time.

Grounds

In its letter dated 12 July 2010 Poznań University of Life Sciences, Experimental and Didactic Section of Tillage and Plant Cultivation Gorzyń, Department of Agronomy, informed the Main Inspector of Plant Health and Seed Inspection about organizational changes at the University of Life Sciences resulting from Regulation no. 141/2009 of the Rector of Poznań University of Life Sciences dated 21 October 2009 on granting new names to certain departments at the Faculty of Agronomy. The Department of Tillage and Plant Cultivation at the Experimental and Didactic Section of Tillage and Plant Cultivation Gorzyń at Poznań



University of Life Sciences, holding an authorization to conduct tests for effectiveness of plant protection chemicals no. 8/2005 dated 1 May 2005, as amended by decisions no. 29/2005 dated 23 December 2005, no. 3/2007 dated 4 April 2007 and no. 2/2008 dated 14 April 2008, received the name of the Department of Agronomy. Poznań University of Life Sciences requested for amending the said authorization in this regard.

Poznań University of Life Sciences, Experimental and Didactic Section of Tillage and Plant Cultivation Gorzyń, Department of Agronomy meets organizational and technical conditions called "Good Experimental Practice – GEP" that ensure correct performance of tests for effectiveness of plant protection chemicals.

Having regard to the above, it was decided as stated.

Instruction

This decision cannot be appealed against. However, a party unsatisfied with the decision may request the Main Inspector of Plant Health and Seed Inspection to review the case within 14 days from receipt of this decision according to Art. 127 § 3 of the Administrative Procedure Code.
