## -/- DECISION no. 4/2022 -/-

Pursuant to section 155 of the Act of 14 June 1960 – Administrative Procedure Code (in Polish Official Journal *Dz.U.* of 2021, item 735, with subsequent amendments) with relation to section 17(8)(2) of the Act of 8 March 2013 on Plant Protection Products (in Polish Official Journal *Dz.U.* of 2020, item 2097), having considered the request of Anadiag SAS Oddział w Polsce (ul. Sadowa 16/22, 95-100 Zgierz) of 20 January 2022, as supplemented by a letter of 10 March 2022 and by a message sent by electronic means on 21 March 2022, I hereby amend decision no. 7/2007 of 28 May, 2007, as amended by decisions no. 1/2010 of 18 March 2010, no. 18/2011 of 18 August 2011, no. 1/2012 of 13 January 2012, no. 3/2014 of 16 April 2014 and no. 10/2018 of 12 October 2018, so that the ruling of said decision shall henceforth read as follows: -/-

I hereby authorise Anadiag SAS Oddział w Polsce (Anadiag SAS, Branch in Poland) to conduct studies evaluating the efficacy of plant protection products from the group of acaricides, bactericides, fungicides, herbicides, insecticides, molluscicides, nematicides, rodenticides, repellents, pheromones and growth regulators in cultivations of grain crops, root crops, oilseed crops, legume crops, vegetable crops, fruit crops and ornamental plant crops, grass crops and crops of plants used in specific fields. The research will be conducted in open field and orchard cultivations, in shelter cultivations, on warehouse premises, in environmental chambers, on premises intended for , and in cultivations of edible mushrooms, on meadows and pastures, on lawns and in areas not used for agriculture. -/-

## -/- Statement of Grounds -/-

By way of the request of 20 January 2022, as supplemented by a letter of 10 March 2022 and by a message sent by electronic means on 21 March 2022, Anadiag SAS Oddział w Polsce (ul. Sadowa 16/22, 95-100 Zgierz), requested that the Chief Plant and Seed Health Inspector amend the scope of the authorisation to conduct studies evaluating efficacy of plant protection products no. 7/2007 of 28 May, 2007, as amended by decisions no. 1/2010 of 18 March 2010, no. 18/2011 of 18 August 2011, no. 1/2012 of 13 January 2012, no. 3/2014 of 16 April 2014 and no. 10/2018 of 12 October 2018. -/-

Given the provision of section 15zzzzy(1) of the Act of 2 March 2020 on Detailed Solutions Related to Preventing, Counteracting and Combating COVID-19, Other Infectious Diseases and Crisis Situations Caused by the Same (in Polish Official Journal *Dz.U.* of 2021, item 2095, with subsequent amendments), which temporarily lifts certain obligations arising from the Act of 8 March 2013 on Plant Protection Products, the Chief Plant and Seed Health Inspector, prior to the amendment of the scope of the authorisation to conduct studies evaluating efficacy of plant protections product, refrained from carrying out the inspection referred to in section 17(6) of the Act on Plant Protection Products. -/-



Fulfilment by Anadiag SAS Oddział w Polsce of the requirements of good laboratory practice was established on the basis of documents enclosed with the request and the letters amending the aforesaid request. -/-

In the light of the above, it was decided as ruled hereinabove. -/-

-/- Instructions -/-

The present decision cannot be appealed against. However, any party objecting to the present decision has the right to request that the Chief Plant and Seed Health Inspector reconsider the case, such request to be filed within 14 days of the service hereof, pursuant to section 127(3) of the Administrative Procedure Code.

During the time limit for filing of the request for reconsideration of the case, the party may waive this right before the public administration agency which issued the decision. As of the date of delivery to the Chief Plant and Seed Health Inspector of the waiver of the right to file the request for reconsideration of the case, the present decision becomes final and binding, which means that the decision is immediately enforceable and there is no possibility to appeal against the same with the Provincial Administrative Court. -/-

If the party does not believe that the decision is consistent with their request and does not wish to exercise their right to request reconsideration of the case, such party may file a complaint against the decision with the Provincial Administrative Court in Warsaw within 30 days of service of the decision on the party. The complaint should be lodged via the Chief Plant and Seed Health Inspector. The fee for the complaint is PLN 200. -/-

Upon their request filed prior to the commencement of or in the course of court proceedings, the party may be granted the right to legal assistance in the form of a total or partial exemption from court fees and the appointment of a barrister or an attorney-at-law insofar as the party proves that they are unable to bear any part of or all of the costs of the proceedings. -/-

Stamp duty fee has been charged in the amount of PLN 1000. -/-
